#### What is this form?

This is a one-page combination of the Comparative Balance Sheet, Income Statement, Exchequer Information Sheet and Bank Account Identifications Sheet.

### Why does this form need to exist?

I'm not sure that it **needs** to exist, but it may save copying and postage for the groups that can use it.

### What groups can use this form?

Groups that:

- 1) Have money (if you don't have money, you fill out the Negative Report Form)
- 2) Had no income other than interest during the quarter
- 3) Had no expenses other than bank fees during the quarter
- 4) Have no inventory or property

## My group meets these criteria, what do I send in for my quarterly report?

This form (filled out and signed) **AND** the **reconciled** bank statements.

## This form frightens me, can't I just keep using the old form?

You betcha! This form is an OPTION, that I developed to save paper and postage.

## We just had one heraldic submission, can't I just write it in on the form?

Nope, sorry, but that would count as activity J The rules are pretty simple, most groups won't qualify, but for those that do, this form may save a BUNCH of paper.

#### Can I use this form for my Domesday?
